## **Legislation Update**

### **Asbestos found in Vehicle Gaskets**

WorkSafe have released a Safety Alert after new vehicles imported into Australia from China by Great Wall Motors Australia and Chery Automotive Australia were found to contain asbestos gaskets. It is also important to remember that many older vehicles (pre 2004) contain asbestos in brakes, clutch linings and gaskets.

#### What action should I take?

When replacing a gasket on a new imported vehicle, contact the local dealership to find out whether the gasket contains asbestos and how to safely handle it if it does. For Great Wall and Chery vehicles, check the model and part numbers on the ACCC's Product Recall website to see if the parts contain asbestos. According to WorkSafe you should assume that gaskets and brake and clutch linings do contain asbestos on all vehicles manufactured before 2004.

### **Harmonisation hits SA and Tasmania**

South Australia passed the WHS Act on 1<sup>st</sup> November 2012 and became the 7<sup>th</sup> jurisdiction to adopt the harmonised WHS laws. The new laws will come into effect on 1<sup>st</sup> January 2013. This brings SA in line with Queensland, NSW, NT, ACT and the Commonwealth jurisdictions where the new laws have already been implemented. Tasmania will also be adopting the new laws on 1 January 2013.

Meanwhile, WA remains committed to the harmonisation process and intends to adopt the model WHS laws but with some amendments to the Act. The 2 month consultation period on the harmonisation proposals closed in October 2012, and was designed to collect comments on potential costs and benefits of the proposed WHS Regulations, as they apply specifically to WA workplaces. A summary report is now due to be submitted for State Government's consideration.

WorkSafe has just released the list of industries it will be focusing on in 2012/13, as follows: Agriculture and Commercial Fishing

Department of Agriculture & Food and Department of Fisheries.

**Compliance Campaign for Indigenous Communities** 

Proactive inspections of the **infrastructure maintenance** and **service provisions** provided to indigenous communities throughout the **Kimberley** region.

### **Construction Industry**

Project work will focus on **Multi Storey Construction Sites** (residential and commercial), **Metropolitan Enforcement** where there are a large number of construction sites in close proximity and **Regional Enforcement Drives** in the **Great Southern** and **Mid-West** regions.

### **Health Hazards**

WorkSafe are planning to focus investigations in the Health, Education and Community services sectors (TAFEs, universities and hospitals) and on Plastics Manufacturers in the Midwest. WorkSafe will run a project investigating the management systems used in larger organisations to manage stress and bullying in the workplace. A project will also be undertaken looking at Communicable diseases investigations of high risk occupations across all industry sectors, with an emphasis on non-English speaking employees.

### **Manufacturing Industry**

Due to high injury rates, WorkSafe will focus on investigating 'Wooden Structural Fitting & Component', 'Other Wood Product' manufacturing, 'Motor Vehicle Body & Trailer', 'Structural Steel Fabricating' and 'Other Fabricated Metal Product' manufacturing.

### **Plant Safety**

A project focused on the safe operation, maintenance and inspection of boilers at laundry operators in the metro and regional areas.

### Other Industries

Proactive investigations are planned for Restaurants, Hardware Building & Garden Suppliers Retailing, Freight Forwarding, Independent Supermarkets, Fast Food Outlets, Heavy Machinery & Scaffolding Hire, Waste Collection, Nature Reserves & Conservation Parks, Corrective Centres.
